Account Name	Online Fixed Rate Bond 165
What is the interest rate?	<p>4.30% Gross/AER fixed until 22 April 2026.</p> <p>AER stands for Annual Equivalent Rate and illustrates what the interest rate would be if interest was paid and added each year.</p> <p>Interest will be added to your account on 22 April each year until the account matures on 22 April 2026. Can Scottish Building Society change the interest rate?	Rates are fixed until after the maturity date. This means that the rate will not change between the date you open your account and the maturity date.
What would be the estimated balance after 12 months based on a £1,000 deposit?	<p>If you deposit £1,000, after 12 months the projected balance would be £1,043.00.</p> <p>This projection is for illustrative purposes only and does not take into account your individual circumstances.</p>
How do I open and manage the account?	You can open an account online – visit <a href="http://scottishbs.co.uk/savings/online-savings">scottishbs.co.uk/savings/online-savings</a> to find out more. The minimum opening deposit amount is £500, up to a maximum of £1,000,000. Deposits can only be made within 14 days of opening the account. No further deposits can be made after this time. Can I withdraw money?	<p>No withdrawals are permitted during the fixed rate period. Early closure is not permitted either.</p> <p>When the Bond matures, we'll write to you asking what you'd like to do with your matured funds. You have the option to withdraw the funds, open a new Bond or transfer the funds in to an Online Saver account.</p>
Additional information	<p>Interest is paid gross without tax deducted. A small proportion of savers may be required to pay tax on savings interest – this should be arranged directly with HMRC through your tax return.</p> <p>Please read our Savings Terms &amp; Conditions leaflet for general conditions which apply to this account.
