## PLEASE READ THE FOLLOWING INFORMATION BEFORE COMPLETING THIS FORM

The UK government has signed, and will be signing, a number of inter-governmental agreements to share tax information, where applicable, with the tax authorities in other countries. The requirement to collect certain information about each customer's tax arrangements is part of UK legislation and as a financial institution we are legally obliged to collect it. We are asking for your tax residency and tax identification numbers (where applicable) and will record this on our records now, but will only disclose this information to the relevant tax authorities if and when we are required to do so under UK law.

The current list of countries that have signed information sharing agreements can be found online by searching for 'OECD Automatic Exchange Portal'.

Your tax residence generally is the country in which you live for more than half the year, but rules differ. Further information is available from the OECD Automatic Exchange Portal (within the section called 'CRS Implementation and Assistance').
